Credible Messenger Mentoring A Lesson in Community Reinvestment

S taff from all divisions of the agency came away with a deepened understanding of Director Clinton Lacey's plan for the Credible Messenger Initiative after undergoing training on February 16 and 17. The training served to: define Credible Messenger Mentoring; provide an understanding of the program components of Credible Messenger Mentoring; provide examples of what Credible Messenger Mentoring looks like; and identify Credible Messengers within the agency.

"The Credible Messenger Initiative" builds on Director Lacey's vision of "love in juvenile justice," said Charles Dotson, who is helping shape the program's structure. "True 'Credible Messengers' believe that every young person, regardless of their current condition or behavior, has unlimited potential and innate greatness; Young people don't care about how much you know until they know about how much you care."

Out of State, On Our Minds

O n February 17, the Contracts Performance Monitoring Unit (CPMU) met with out-of-state Residential Treatment Centers (RTC) in an effort to enhance relationships, increase agency transparency and share information. The DYRS Case Management division gained valuable knowledge to aid in placing our youth, and RTCs learned about the community-based approach that the agency believes in.

DYRS Program Manager Jose Dearteaga contributed a guide to funding options for Medicaid processes and placement, and CPMU staff Nancy Fisher and Dr. Markeeta Barnes introduced an objective, outcome-based evaluation tool for assessing RTCs intended to improve performance by enhancing DYRS oversight, promoting vendor accountability and measuring program performance across key indicators.

A Truth Hard to Swallow

C ovenant of Peace organizers, facilitators and volunteers returned to the Youth Services Center on Saturday, February 20 to remind young women about the pillars they promised to adhere to at January's all girl Covenant of Peace event. 23 young ladies, and dozens of guests dedicated to ensuring our youth's commitment to nonviolence, focused on one of the pillars specific to the girls' event – "The Power of the Tongue."

The girls participated in dramatic play that focused on the power of words we use. What resonated most with the girls is remembering that the tongue is a strong muscle, and that words said have the power to build someone up or cut someone down. This realization heightened their sense of responsibility to each other as women, to the Covenant they signed, and to themselves.

DYRS Quarterly Networking Breakfast

O n February 17, youth and staff attended DYRS' Quarterly Networking Breakfast at the Pepco Edison Place Gallery, where they met with more than 50 employers and talent acquisition consultants about possible employment opportunities and internships. Recruiters offered perspective on "Bridging the Gap between Education and Workforce".

Group Orientations for Employment Opportunities

The Office of Workforce Development (WFD) is conducting group orientations for all youth interested in unsubsidized employment opportunities.

The orientation process takes approximately two to three hours, and consists of registration form completion, CASAS Testing and career assessment and planning.
